


Income for the parish is primarily from parishioner contributions. The parish, however, also benefits from investment earnings, rental income from flats owned by the parish and rental income from hiring out the parish facilities.



Expenses for the parish are largely determined by contributions to the Archdiocese for the support of the clergy, contributions to the insurance of parish assets and repairs and maintenance items. In the current year, repairs and maintenance were low in comparison to recent years but are expected to become a significant item of expenditure this year and in the future.
